Our Social Networking and E-Commerce platform can be accessed by over 120 countries, and is translated in to 12 languages. In addition to owning and operating our own for-profit niche social networks, we provide access to our technology platform to other industry businesses by charging a licensing fee based on a percentage of their annual profits and/or number of end-users on the social e-commerce network. The niche industries that we have targeted for generating online advertising and e-commerce revenue from, total more than \$2B a year in online ad spending, and \$4T a year in retail sales.
